


1d. Land



It is a criminal offence, if without reasonable excuse, you fail to do this, or the notification you give contains false or misleading information or you are reckless as to whether the information is true and not misleading.

Under Section 29 of the Localism Act 2011 the details contained within this form will be published on the Parish/Neighbourhood Council's and City Council's websites. This original form will also be available to view at the City Council offices by members of the public.
