


#### 1d. Land

- (b) the tenant is a body in which you or any **relevant person** has a beneficial interest.

For example you and any relevant person is a partner or a Director in the tenant company or has securities in the tenant company.



  - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
  - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which any relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

It is a criminal offence, if without reasonable excuse, you fail to do this, or the notification you give contains false or misleading information or you are reckless as to whether the information is true and not misleading.

Under Section 29 of the Localism Act 2011 the details contained within this form will be published on the Parish/Neighbourhood Council's and City Council's websites. This original form will also be available to view at the City Council offices by members of the public.
