Any beneficial interest in securities (shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme and other securities of any description, other than money deposited with a building society) of a body where -

- (b) either-
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which any relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
